Call for Director nominations

National Precast's Board of Directors will be re-elected at the November AGM in Melbourne. Members of the Board play a crucial role in identifying the strategic direction and decision making of the organisation.

Clause 25.8 of the Constitution states that:

Each Director shall hold office from the time of their appointment until the following Annual General Meeting when they shall retire but be eligible for re-election at the Annual General Meeting if otherwise qualified. All nominations for the Board, including retiring Directors wishing to be re-elected, shall nominate for election at least thirty (30) days before the Annual General Meeting.

Nominations are being sought from Precaster members for National Precast Director (Board) positions. To nominate, your company needs to have been a <u>financial</u> Precaster member for a minimum of two years. Nominations <u>must</u> be received by Sarah before close of business on <u>Thursday 13th August</u>. Nominees should be aware of and comply with the director duties for a not-for-profit company limited by guarantee – more information can be found on the <u>AICD website</u>.
