NCC (BCA) to be available free online

From the 2015 edition onwards, the National Construction Code (including the Building Code of Australia) will be available for free online. This decision will make the Code more accessible and follows heavy lobbying by the Australian Construction Industry Forum, National Precast and others. In fact, National Precast raised this issue as well as the possibility of increasing the annual review cycle to 3 years, with Australian Building Codes Board Chairman John Thwaites at an industry lunch in Melbourne last year. This change to the review cycle will also go ahead, with annual reviews becoming 3 yearly from the 2016 edition.

AS 3850 and National Code update



The most recent meeting of the committee reviewing AS 3850 was held this week in Melbourne. The meeting was well attended. At the meeting, the committee finished reviewing public comments and finalised discussions on statistical methods to be adopted for testing. The Standard is now at a point where final style and formatting changes will be undertaken by SA. The document will then be issued to committee members for checking and the final document will be voted upon by committee members. Thanks to NP reps Jeff Stratford and Kevin (Crompton for all their hard work.

Note - As we know, once AS 3850 is finalised, the National Code is to be reviewed. Under new advice from the Minister for Employment, we understand that national codes are likely to be abolished and republished as guides (subject to ratification by the Minister). Guides would still be the highest available reference document, but would not have legal status as do codes of practice. This is likely to mean that whilst guides will have more weight than standards, their content will be able to be tested in court.
