6. REPRESENTATION/ADVOCACY

Australasian Certification Authority for Reinforcing & Structural Steels (ACRS)

National Precast representative

ITW

The ARCS board accepted in principle the independent report and there is a genuine prospect that there will be a complete restructure of the company and scheme rules. These changes would seek to:

- Improve its relevance to the broader community of stakeholders;
- Move to be and act visibly more independent from the steel industry;
- Address some governance issues and the functioning of the board and management of the company;
- Expand the scheme's scope to cover other compliance auditing and oversight requirements being requested by industry stakeholders; and

• Attract new certificate holders from a broader range of supplier types.

Because there is not unanimous agreement on all changes and some board members are affected more than others, the change process is likely to be slower than many stakeholders would like. It should be completed by the end of 2017.

Steel Processor Working Group

Emissions Reduction Fund Technical Working Group for Cement & Concrete

Mathew has resigned his position and is no longer active on this working group. Due to the loose ties to precast, Sean O'Gorman will cover this position for the foreseeable future. The working group's project manager has requested feedback on a proposal to reduce the amount of clinker produced in Australia. The aim of the proposal sees Australian cement produces being "pushed" via financial penalties to import more clinker, thus reducing Australia's energy / emissions during the cement making process – this method has been terminated due to feedback. As many of the cement manufactures in Australia already import clinker, there would be no foreseeable negative effect on the precast industry. As NP supports local manufacturing, it has been suggested that the working group look at a proposal that would assist

cement manufactures in reducing emissions via investment in alternative fuel and raw materials rather than simply exporting emissions and jobs to another country in return for clinker.

ACRA Guide to Concrete Repair and Protection (precast section) Working Group

No update since previous report, when Trent had reviewed draft material provided by the Australian Precast Concrete Repair Association.

WHS Authorities

Safe Work Australia (SWA): 2008 National Code of Practice

Progress has taken a "many pronged" approach. NP has been in discussion with SWA and Standards Australia in relation to the ownership of The "DRAFT NCoP, Tilt-up and Precast Concrete in Building Construction" dated 7th December, 2012 including Appendix H. While the issue of ownership still hasn't been resolved, the Acting Director for SWA, Stephanie Creagh has acknowledged that the NCoP, 2008 is now out of date. Stephanie is briefing the SWA executive on the need to expedite an update, noting however, that there will be difficultly in any new document carrying weight in WA and Vic who have not adopted the model legislation. As such, she is supportive of NP making contact with state workcover contacts (in particular the Victorian and Qld members of the SWA Strategic Issues Group), to reinforce the need for the Code/Guide update to be expedited.

Roads' Authorities

TMR

There has been ongoing liaison with TMR on standard and skew deck units. This is being considered and TMR will advise once this process is completed.

NP will be organising a meeting with TMR for a postponed date in late March/early April.

Main Roads WA

PERMAcast has advised that Main Roads WA is undertaking a major review of specifications and has requested NP involvement - no progress on this item to report.

Australian Standards

AS 3600 Concrete Structures National Precast representative

Members of the working group held a meeting early December. The areas of fire, earthquake, serviceability and construction were the key topic areas covered. As part of this revision process, section 17 - Construction and Materials has scope to include content related to precast. A copy of section 17 will be provided shortly for review and comment from NP members.

Action – Nagesh to provide section 17 for member review.

BD-043 Committee AS3610 Formwork BD-043 Main Committee and Working Group 1 & 2 Main Committee/WG2 Alan Morrison Ultrafloor National Precast representatives WG1 Peter Webb

The activities of BD-043 Working Groups for Parts 2 & 3 of AS3610 were placed on hold in early 2016 to allow Part 1 to be progressed and put out for public comment. Part 1 will be going out for public comment in February. This is a 9-week process and the next meeting will be scheduled 1-2 weeks after the comment period has closed. It is proposed that WG2 & WG3 reconvene late March 2017, which is a re-schedule of the meeting that was originally planned for late January / early February. It is still the intention that NP produce a 10-tone plastic colour chart showing 10 tones for off-form precast, using Pantone colours as its basis. While the chart will show grey colour tones, it will be able to be used to determine tonal variations for any colour of off-form concrete.

Action – Alan commence involvement with work on parts 2 and 3. Develop colour tone chart.
