#### Australasian Certification Authority for Reinforcing & Structural Steels (ACRS) **Bob Connell**

# National Precast representative

Whilst slow, the restructure of the ACRS board, scheme, governance and fee structure is progressing. A new funding model was approved at the last board meeting and will start to be rolled out for certificate holders shortly. The new fees model will:

- remove the "levy" based on tonnage produced,
- move certification to a "fee for service" model.

ITW

- be the same for everyone and transparent, and
- be phased in over a number of years.

Changes have been made to the scheme to enable certificate holders to apply for exemptions from the "all products, all locations" requirements. The structure of ACRS will be changed to encourage a more directly responsible and involved board (smaller & skills based) and a member council. This will require constitutional change which is expected to be proposed for approval before year end. The CEO role will be converted to a full-time employee position. Recruitment for this position will be via the new board.

Action – Bob to continue updating NP on all progress.

Safe Work Australia (SWA): Guide / National Code of Practice Working Group

Participants: Sarah Bachmann (NP), Sean O'Gorman (NP), Peter Webb (Hanson), Geoff Fletcher (Euro Precast), Kevin Crompton (Ultrafloor), Rod Mackay-Sim, Nicole Bartels (Hanson)

As discussed at the May meeting, SWA are now moving forward with the update of the National Code of Practice. A working group has been formed and met with SWA in their Canberra office in early June for a workshop. Progress was made on a range of topics. The group agreed that the document should, where possible, follow the same layout and flow of the standard (AS3850.2). Since June, the working group has been heavily involved with assisting SWA with ideas, feedback and support. Once a draft is produced all NP Members will be given a period for review and comment. Action – Working group to continue working with SWA on revised draft guidance material.

# Workplace Health and Safety Queensland

NP was contacted by Workplace Health and Safety Queensland regarding the development of a "Stacked Material" alert. Working closely with our Queensland civil precaster memberss, NP collected, collated, and provided general feedback. The alert, (with most of NP's suggestions absent) was published and distributed via the Workplace Health and Safety Queensland website, and via NP's WHS enews.

# Roads' Authorities

# QDTMR

Sarah Bachmann (NP), Graham Underwood (Rocla), Glenn Degenhardt (Humes), and Andrew Ruffles (CPAA) attended a meeting with QDTMR to meet new staff and discuss high level progress on MRTS 24, 25 and 70. With the staffing changes, progress with QDTMR has slowed due to the need to re-establish relationships.

NP and CPAA Members have reviewed MRTS 70 and comments have been provided to QDTMR.

# Action – Continue to liaise with TMR.

# Austroads

NP has been engaged in continuous consultation with Richard Edwards (DPTI & Austroads) regarding the development of a national prequalification system. After many years and numerous rounds of consultation, the Austroads board is reviewing what Richard has suggested is a document that is almost ready for implementation. In our latest round of consultation, NP put forward significant changes aimed to protect the industry from another ambiguous document. Richard, who seems to be the main force behind the system, will be departing DPTI shortly. This may mean that Austroads will lose motivation to continue the development of a national prequalification system. Action – NP to continue providing consultation to Austroads.

### <u>Australian Standards</u> AS 3600 Concrete Structures National Precast representative

The BD-002 committee has been busy with several intensive sessions aimed at getting a range of revisions to multiple sections completed, prior to public comment. While all efforts are being made to have all sections ready, it is likely that some may not be prepared in time, as there is a significant amount of work to be done by subcommittees. Members will be advised of the public consultation period when confirmed by Standards Australia.

Going forward, Standards Australia are working towards having only one representative from each nominating organization on standards' committees. Jeff's vacancy will therefore not be replaced. A working group will be formed to undertake the development of AS 3850.3 which will apply to the use of prefabricated concrete elements in civil construction. The organisational composition of this group is being finalised by Standards Australia with NP's assistance. Expressions of interest to participate in this group will be issued shortly, and any interested NP members may contact Sean in the meantime.

Members in attendance at May's meeting would have listened to a presentation from Tom Clark. Since then, NP has sent two Representation & Advocacy emails requesting feedback regarding Tom's proposals. Members' feedback will be compiled and presented to the NP representatives shortly.
