








The Customer requires the Supplier to complete the Supply</p><p>B. The Supplier has agreed to complete the Supply in accordance with this Contract.</p><p>C. The parties wish to evidence their agreement in writing on the terms of this Contract.</p></div><div><p>1. DEFINITIONS AND INTERPRETATION</p><p>1.1 Definitions</p><p>In this Contract:</p><p>Business Day means any day other than:</p><p>(a) a Saturday, Sunday or public holiday in the place where the Site is located or the Goods are being manufactured, or</p></div><div><p>(b) supply and installation of the Goods at the Site.</p><p>WHS Laws means all relevant work, health and safety laws.</p><p>Working Day means all days other than Business Days and days on which Supplier Personnel are rostered day off.</p><p>1.2 Interpretation</p><p>In this Contract:</p><p>(a) a reference to a clause or schedule is a reference to a clause of or schedule to this Contract;</p><p>(b) references to including, includes and include must be read as if followed by (without limitation);</p><p>(c) a reference to a party to this Contract includes its executors, administrators, substitutes, successors and permitted assigns.</p></div></div>
