Precaster Membership Options

Master precaster

This is the highest and most prestigious membership category for precasters.

To be awarded Master Precaster status, you must have been manufacturing precast for 5+ years and you must pass a *Master Precaster Membership Audit*. This audit verifies your industry contribution and track record, as well as your technical and factory capability, your quality and safety management, your environmental compliance and your financial stability.

Services ONLY available to Master Precasters

- Promote yourself as a Master Precaster and receive Tender Requests.
- · Get coverage in national industry magazines.
- Participate in national events.
- Meet with authorities.
- Represent National Precast on Standards' and other committees.
- Receive a Process Improvement Report (identifying opportunities to improve quality and safety management).
- Priority access to any special or one-off member-only opportunities

As well, Master Precasters can access the full suite of membership services that are available to precaster members, including help when you need it, all member newsletters, case studies, the ability to register for member events and factory visits, precast-related standards, Cordell precast project reports, the internship program, input on standards and codes and a strategic planning session and report.

Precaster

To be a Precaster you must have been manufacturing precast for 2+ years.

Services: Precasters can access help when you need it, all member newsletters, case studies, the ability to register for member events and factory visits, precast-related standards, Cordell precast project reports, the internship program, input on standards and codes and a strategic planning session and report.

PP Provisional Precaster

Provisional Precasters will have manufactured precast for under 2 years. After 2 years of membership, you'll need to apply for Precaster membership.

Services: As a Provisional Precaster you can be mentored by a Master Precaster and will receive a limited range of services for your maximum 2 year membership period. These include help when you need it, all member newsletters, the ability to register for member events and factory visits, precast-related standards, the internship program, Cordell precast project reports and a strategic planning session and report.

AP Affiliate Precaster

At a minimal cost, being an Affiliate Precaster allows precasters to experience some of the benefits of membership.

Services: You will receive a selection of services including a copy of the Precast Concrete Handbook, all member newsletters, the ability to register for member events, magazine subscriptions, input on standards and codes, and the ability to participate in the internship programme.

Membership Entry Requirements

As well as complying with National Precast's Codes of Conduct, the following requirements apply:

- Master Precaster you must have been manufacturing precast for 5+ years AND passed a Master Precaster
 Membership Audit;
- Precaster you must have been manufacturing precast for 2+ years;
- **Provisional Precaster** you must have been manufacturing precast for less than 2 years. A 2 year maximum membership term applies after which you'll apply to become a Precaster; or
- Affiliate Precaster a basic membership for any precast manufacturer.

Membership Fees

All fee types are based on the precaster's ex-works turnover (excluding cartage, installation and GST) and can be paid in full, monthly or quarterly installments by arrangement. Fees are treated as STRICTLY CONFIDENTIAL by the CEO and accounts staff.
