Membership of National Precast is in accordance with the Constitution of National Precast Concrete Association Australia Limited (email exec@nationalprecast.com.au to request a copy). When claiming membership, members can only use the National Precast logo for their specific membership category. Application is subject to approval by the Board of Directors (refer www.nationalprecast.com.au for criteria). A minimum term of 12 months applies to new membership applications. Membership is automatically renewed for a further 12 months each year on 1st July. Resignations must be submitted in writing and fees will be payable until such written advice is received by the Association.
